4	In paragraph (c) – <p style="text-align: center;">A. in subsection (6), insert after the words “under this section, take”, the word “all”;</p> <p style="text-align: center;">B. in subsection (7)(a), insert after the word “suspect”, the words “or his authorised representative”; and</p> <p style="text-align: center;">C. in subsection (8), insert after the words “or a suspect”, the words “or his authorised representative”.</p>
8	In subsection (5)(a) – <p style="text-align: center;">A. by inserting after the words “notice to be”, the words “filed in the High Court and”; and</p> <p style="text-align: center;">B. by deleting the words “and filed in the High Court”.</p>
13	In paragraph (a), by deleting the word “ten” and substituting the word “twenty-eight” .
24	Renumber the existing paragraphs (a) and (b) as paragraphs (b) and (c) respectively and insert a new paragraph (a) as follows: <p style="text-align: center;">“(a) by inserting after the words “files an indictment”, the words “under section 6(2)”;”.</p>
27	In paragraph (7), by deleting the word “fourteen” and substituting the word “twenty-eight” .
