- (d) Would the Attorney General indicate precisely what sum was paid to each of the two lawyers?
- (e) Since no mention was made of the firms Afa Law (which received \$6,099,348.09) and Alix and Partners (which received \$20,903,070.98) when the Attorney General announced the “A-Team”, would the Attorney General explain why not; and when and how did these two entities get involved in the provision of the services contracted for with the “A-Team”?
- (f) Would the Attorney General indicate whether his office or the “A-Team” reported any matter(s) regarding the investigations of the “A-Team” to the Police? And if so, what is the status of this/these investigations?
