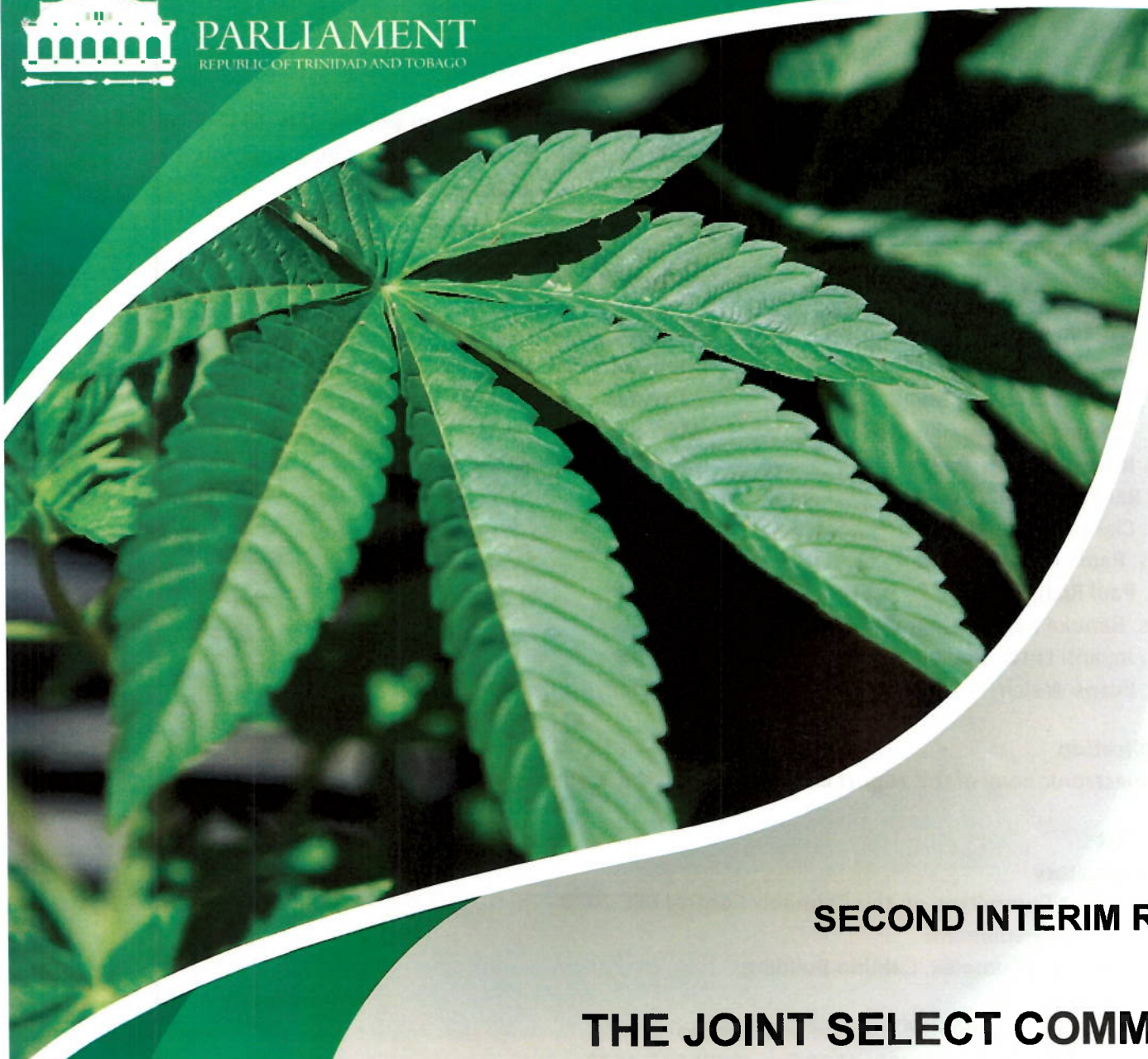

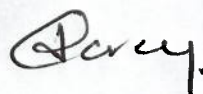
Mandate

2. Since its appointment, your Committee has held a total of thirteen meetings to date.

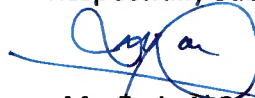
REPORT

3. Following the presentation of its First Interim Report, dated December 14, 2020, your Committee has continued to work assiduously on its mandate.

4. Your Committee has since completed the clause-by-clause examination of the Bill and all stakeholders' comments have been taken into account. Your Committee has also engaged in significant and very useful consultations with Cannabis Licensing Authorities of the region.

5. While considerable progress has been made, your Committee requires an additional period of two (2) months to fully complete its work. Your Committee therefore seeks an extension to **May 31, 2021** to submit a comprehensive report to the House.
