ESTABLISHMENT OF COMMITTEE AND TERMS OF REFERENCE

2. Your Committee was mandated to report to the House within six (6) weeks of its appointment.

At that meeting, your Committee also agreed that in accordance with Standing Order 80(5) of the House of Representatives, a quorum would constitute three (3) members, inclusive of the Chair.

6. Your Committee also recognised the need for the input of other special interest groups and invited written comments from these groups on the Copyright (Amendment) Bill, 2004.

7. To date your Committee has received two (2) written submissions.

EXTENSION OF TIME TO REPORT

8. In submitting this Interim Report to the Parliament, your Committee wishes to report that it is unable to complete consideration of the Bill before it, and seeks an extension of six (6) weeks in order to present a final report.
