ESTABLISHMENT OF COMMITTEE AND TERMS OF REFERENCE

1. Pursuant to Standing Order 83 (8) of the House of Representatives, your Committee was established by resolution at a Sitting of the House held on Friday October 30, 2009 with a mandate to consider and report on HOR Bill No. 18 of 2009 entitled “An ACT for the incorporation of the Trinidad and Tobago Football Federation and for matters incidental thereto”.
