AN ACT to vary the appropriation of the sum the issue of
which was authorized by the Appropriation Act,
2005

[Assented to 27th January, 2006]

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows:—

1. This Act may be cited as the Finance (Variation Short title
of Appropriation) (2005) Act, 2006.

Construction of Act
No. 21 of 2004

2. In this Act and in any other written law, a reference to the Appropriation Act, 2005 shall be construed as a reference to that Act as for the time being varied or otherwise amended by any Finance (Variation and Supplementation of Appropriation) Act, passed before this or that other written law.

Increase in Heads of
Expenditure
Schedule

3. The sums appropriated to the Heads of Expenditure set out in the First Column of Part I of the Schedule to this Act by the Appropriation Act, 2005 are hereby increased by the amounts specified in the Second Column of that Part.

Reduction in Head
of Expenditure

4. The sums appropriated to the Heads of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation Act, 2005 are reduced by the amounts specified in the Second Column of that Part.

Sum appropriated
in respect of Head
specified in Part II
may be utilized

5. The sums appropriated in respect of the Heads of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation Act, 2005 and not utilized at the commencement of this Act and not exceeding the amounts specified as reduced in the Second Column of Part II of the Schedule to this Act may be utilized, notwithstanding anything contained in the Exchequer and Audit Act, for the discharge of any liability incurred by reason of the increase in the Expenditure in respect of the Heads of Expenditure specified in Part I of the Schedule.
