AN ACT to vary the appropriation of the sum the issue
of which was authorized by the Appropriation
(Financial Year 2015) Act, 2014

[Assented to 12th June, 2015]

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows:

1. This Act may be cited as the Finance (Variation of Short title
Appropriation) (Financial Year 2015) Act, 2015.

Increase in Heads
of Expenditure

2. The sums appropriated to the Heads of Expenditure specified in the First Column of Part I of the Schedule to this Act by the Appropriation (Financial Year 2015) Act, 2014 are increased by the amounts specified in the Second Column of that Part.

Reduction in Heads
of Expenditure

3. The sums appropriated to the Heads of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation (Financial Year 2015) Act, 2014 are reduced by the amounts specified in the Second Column of that Part.

Sums appropriated
in respect of Heads
specified in Part II
may be utilized

4. The sums appropriated in respect of the Heads of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation (Financial Year 2015) Act, 2014 and not utilized at the commencement of this Act and not exceeding the amounts specified as reduced in the Second Column of Part II of the Schedule to this Act may be utilized, notwithstanding anything contained in the Exchequer and Audit Act, for the discharge of any liability incurred by reason of the increase in the expenditure in respect of the Heads of Expenditure specified in the First Column of Part I of the Schedule to this Act.
