AN ACT to vary the appropriation of the sum the issue of which was authorized by the Appropriation (Financial Year 2015) Act, 2014 and varied by the Finance (Variation of Appropriation) (Financial Year 2015) Act, 2015

[Assented to 26th January, 2016]

ENACTED by the Parliament of Trinidad and Tobago as Enactment follows:

1. This Act may be cited as the Finance (Variation of Short title Appropriation) (Financial Year 2015) Act, 2016.

<p>Interpretation Act No. 16 of 2014 Act No. 9 of 2015</p>	<p>2. In this Act, “the Appropriation Act, 2015” means the Appropriation (Financial Year 2015) Act, 2014 as amended by the Finance (Variation of Appropriation) (Financial Year 2015) Act, 2015.</p>
<p>Increase in Head of Expenditure Schedule</p>	<p>3. The sum appropriated to the Head of Expenditure specified in the First Column of Part I of the Schedule to this Act by the Appropriation Act, 2015 is increased by the amount specified in the Second Column of that Part.</p>
<p>Reduction in Head of Expenditure Schedule</p>	<p>4. The sum appropriated to the Head of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation Act, 2015 is reduced by the amount specified in the Second Column of that Part.</p>
<p>Sum appropriated in respect of Head specified in Part II may be utilized Schedule</p>	<p>5. The sum appropriated in respect of the Head of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation Act, 2015 and not utilized at the commencement of this Act may be utilized, notwithstanding anything contained in the Exchequer and Audit Act, for the discharge of any liability incurred by reason of the increase in the expenditure in respect of the Head of Expenditure specified in the First Column of Part I of the Schedule to this Act.</p>
