THE FINANCE (VARIATION OF APPROPRIATION) (1998)  
BILL, 1999

**Explanatory Note**

(These notes form no part of the Bill but are intended only to indicate its general purport)

The Bill seeks to vary the appropriation provided for by the Appropriation Act, 1998 and to authorize the utilization of any sums accruing from a reduction in expenditure under certain Heads of Expenditure for the purpose of meeting any liability incurred through the increase in expenditure under other Head 18: Ministry of Finance.

## **BILL**

AN ACT to vary the appropriation of the sum the issue  
of which was authorized by the Appropriation  
Act, 1998.

ENACTED by the Parliament of Trinidad and Tobago as Enactment  
follows:—

**1.** This Act may be cited as the Finance (Variation of Short title  
Appropriation) (1998) Act, 1999.

Construction of  
Act No. 21 of 1998

**2.** In this Act and in any other written law, a reference to the Appropriation Act, 1998, shall be construed as a reference to that Act as for the time being varied or otherwise amended by any Finance (Variation of Appropriation) Act, passed before this or that other written law.

Increase in Head of  
Expenditure  
Schedule

**3.** The sum appropriated to the Head of Expenditure set out in the First Column of Part I of the Schedule by the Appropriation Act, 1998, is hereby increased by the amount specified in the Second Column of that Part.

Reduction in Heads  
of Expenditure

**4.** The sums appropriated to the Heads of Expenditure set out in the First Column of Part II of the Schedule by the Appropriation Act, 1998, are reduced by the amounts specified in the Second Column of that Part.

Sums appropriated  
in respect of Heads  
set out in Part II  
may be utilised  
Chap. 69:01

**5.** Notwithstanding anything contained in the Exchequer and Audit Act, the sums appropriated in respect of the Heads of Expenditure set out in the First Column of Part II of the Schedule by the Appropriation Act, 1998, and unissued at the commencement of this Act may be utilised for the discharge of any liability incurred by reason of the increase in the expenditure in respect of the Head of Expenditure set out in Part I of the Schedule.
