THE FINANCE (SUPPLEMENTATION AND VARIATION OF
APPROPRIATION) (1998/1999) BILL, 1999

Explanatory Note

(These notes form no part of the Bill but are intended only
to indicate its general purport)

The Bill seeks to supplement and vary the appropriation provided for by the Appropriation Act, 1998/1999 and to authorize the utilization of any sums accruing from a reduction in expenditure under certain Heads of Expenditure for the purpose of meeting any liability incurred through the increase in expenditure under other Heads.

BILL

AN ACT to supplement and vary the appropriation of the sum of the issue of which was authorized by the Appropriation Act, 1998/1999.

ENACTED by the Parliament of Trinidad and Tobago as ^{Enactment} follows:—

1. This Act may be cited as the Finance ^{Short title} (Supplementation and Variation of Appropriation) (1998/1999) Act, 1999.

Further issue from
the Consolidated
Fund

2. A further issue from the Consolidated Fund in the sum of eighty seven million, eight hundred and twenty thousand, nine hundred and twenty eight dollars is authorized for meeting expenditure for the service of the financial year ending September 30, 1999 and appropriated in respect of the following Head indicated in the schedule to the Appropriation Act, 1998/1999 entitled:

19—CHARGES ON ACCOUNT OF THE PUBLIC DEBT

Increase in Heads of
Expenditure—
Schedule

3. The sums appropriated to the Heads of Expenditure specified in the First Column of Part I of the Schedule by the Appropriation Act, 1998/1999 are increased by the amounts specified in the Second Column of that Part.

Reduction in Heads
of Expenditure

4. The sums appropriated to the Heads of Expenditure specified in the First Column of Part II of the Schedule by the Appropriation Act, 1998/1999 are reduced by the amounts specified in the Second Column of that Part.

Sums appropriated
in respect of Heads
specified in Part II
may be utilised

5. The sums appropriated in respect of the Heads of Expenditure specified in the First Column of Part II of the Schedule to the Appropriation Act, 1998/1999 and not utilised at the commencement of this Act and not exceeding the amount specified as reduced in the Second Column of Part II of the Schedule may be utilised, notwithstanding anything contained in the Exchequer and Audit Act, for the discharge of any liability incurred by reason of the increase in expenditure in respect of the Heads of Expenditure specified in Part I of the Schedule.
