issue of which was authorized by the Appropriation
Act, 1999/2000.

THE FINANCE (VARIATION OF APPROPRIATION)
(1999/2000) BILL, 2001

Explanatory Note

(These notes form no part of the Bill but are intended only to indicate its general purport)

The Bill seeks to vary the appropriation provided for by the Appropriation Act, 1999/2000 and to authorize the utilization of any sums accruing from a reduction in expenditure under one Head of Expenditure for the purpose of meeting any liability incurred through the increase in expenditure under other Heads.

BILL

AN ACT to vary the appropriation of the sum of the issue of which was authorized by the Appropriation Act, 1999/2000.

ENACTED by the Parliament of Trinidad and Tobago as Enactment follows:—

1. This Act may be cited as the Finance (Variation of Short title Appropriation) (1999/2000) Act, 2001.

Construction of
Act No. 30 of 1999

2. In this Act and in any other written law, a reference to the Appropriation Act, 1999/2000 shall be construed as a reference to that Act as for the time being varied or otherwise amended by any Finance (Variation of Appropriation) Act, passed before this or that other written law.

Increase in Heads of
Expenditure
Schedule

3. The sums appropriated to the Heads of Expenditure set out in the First Column of Part I of the Schedule to this Act by the Appropriation Act, 1999/2000 are hereby increased by the amounts specified in the Second Column of that Part.

Reduction in Head of
Expenditure

4. The sum appropriated to the Head of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation Act, 1999/2000 is reduced by the amount specified in the Second Column of that Part.

Sums appropriated
in respect of the
Head specified in
Part II may be
utilised

5. The sum appropriated in respect of the Head of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation Act, 1999/2000 and not utilised at the commencement of this Act but not exceeding the amount specified as reduced in the Second Column of Part II of the Schedule to this Act may be utilised, notwithstanding anything contained in the Exchequer and Audit Act, for the discharge of any liability incurred by reason of the increase in the expenditure in respect of the Heads of Expenditure specified in Part I of the Schedule.
