THE APPROPRIATION BILL, 2004

Explanatory Note

(These notes form no part of the Bill but are intended only to indicate its general purport)

This Bill seeks to provide for the Service of Trinidad and Tobago for the financial year ending September 30, 2004 by authorizing the issue from the Consolidated Fund of the sum of sixteen thousand and forty-two million, one hundred and sixteen thousand, nine hundred and thirty-two dollars (\$16,042,116,932).

AN ACT to provide for the Service of Trinidad and Tobago

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows:—

1. This Act may be cited as the *Appropriation Act*, Short title
2004.

Issue from the
Consolidated Fund
authorized

2. (1) The issue from the Consolidated Fund of the sum of sixteen thousand and forty-two million, one hundred and sixteen thousand, nine hundred and thirty-two dollars (\$16,042,116,932) is hereby authorized for meeting expenditure for the service of the financial year ending on the 30th day of September, 2004 under the Heads of Expenditure specified in the Schedule hereto.

Schedule

(2) The sum specified in the Schedule opposite to each Head of Expenditure is hereby appropriated out of the said sum of sixteen thousand, and forty-two million, one hundred and sixteen thousand, nine hundred and thirty-two dollars (\$16,042,116,932) for the purpose specified in relation to that Head in the Estimates of Expenditure for the said financial year.

Commencement

3. This Act shall be deemed to have come into force on the 1st day of October, 2003.
