THE FINANCE (SUPPLEMENTATION AND VARIATION
OF APPROPRIATION) BILL, 2008

Explanatory Note

(These notes form no part of the Bill but are intended only to indicate its general purport)

The object of the Bill is to supplement and vary the appropriation provided for by the Appropriation Act, 2008 and to authorize the utilization of any sums accruing from a reduction of expenditure under certain Heads of Expenditure for the purpose of meeting any liability incurred through the increase in expenditure under other Heads.

BILL

ENACTED by the Parliament of Trinidad and Tobago as Enactment follows:—

1. This Act may be cited as the Finance Short title (Supplementation and Variation of Appropriation) Act, 2008.
