THE FINANCE (SUPPLEMENTATION AND VARIATION OF
APPROPRIATION) (FINANCIAL YEAR 2014) BILL, 2015

Explanatory Note

(These notes form no part of the Bill but are intended only to indicate its general purport)

The object of the Bill is to supplement and vary the appropriation provided for by the Appropriation (Financial Year 2014) Act, 2013 and to authorize the utilization of any sums accruing from a reduction of expenditure under certain Heads of Expenditure for the purpose of meeting any liability incurred through the increase in expenditure under other Heads.

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows:

1. This Act may be cited as the Finance Short title
(Supplementation and Variation of Appropriation)
(Financial Year 2014) Act, 2015.

Schedule

2. A further issue from the Consolidated Fund in the sum of four hundred and fifty million dollars is authorized for meeting expenditure for the service of the financial year ending September 30, 2014 and appropriated in respect of the Heads of Expenditure set out in Part I of the Schedule to this Act.

Increase in Heads
of Expenditure
Act No.14 of 2013

3. The sums appropriated to the Heads of Expenditure specified in the First Column of Part I of the Schedule to this Act by the Appropriation (Financial Year 2014) Act, 2013 are increased by the amounts specified in the Second Column of that Part.

Reduction in Heads
of Expenditure

4. The sums appropriated to the Heads of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation (Financial Year 2014) Act, 2013 are reduced by the amounts specified in the Second Column of that Part.

Sums appropriated
in respect of Heads
specified in Part II
may be utilized

5. The sums appropriated in respect of the Heads of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation (Financial Year 2014) Act, 2013 and not utilized at the commencement of this Act may be utilized, notwithstanding anything contained in the Exchequer and Audit Act, for the discharge of any liability incurred by reason of the increase in the expenditure in respect of the Heads of Expenditure specified in the First Column of Part I of the Schedule to this Act.
