THE APPROPRIATION (FINANCIAL YEAR 2016) BILL, 2015

Explanatory Note

(These notes form no part of the Bill but are intended only to indicate its general purport)

The Bill seeks to provide for the service of Trinidad and Tobago for the financial year ending September 30, 2016 by authorizing the issue from the Consolidated Fund of the sum of fifty-four thousand, seven hundred and sixty-two million, ninety-four thousand, nine hundred and sixty-five dollars (\$54,762,094,965).

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows:

1. This Act may be cited as the Appropriation Short title
(Financial Year 2016) Act, 2015.

Issue from the
Consolidated Fund
authorized

2. (1) The issue from the Consolidated Fund of the sum of fifty-four thousand, seven hundred and sixty-two million, ninety-four thousand, nine hundred and sixty-five dollars (\$54,762,094,965) is authorized for meeting expenditure for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2016, under the Heads of Expenditure specified in the First Column of the Schedule.

Schedule

(2) The sum specified in the Second Column of the Schedule, in relation to the Head of Expenditure specified in the First Column of the Schedule, is appropriated out of the sum of fifty-four thousand, seven hundred and sixty-two million, ninety-four thousand, nine hundred and sixty-five dollars (\$54,762,094,965) for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2016.

Commencement

3. This Act is deemed to have come into force on the 1st day of October, 2015.
