A person, including a retired Prime Minister, is eligible on every fifth anniversary of the date he ceased to be Prime Minister for a revised Prime Minister’s pension equivalent to –</b></p>

	<p>(a) the salary payable to the incumbent on that date; or</p> <p>(b) three-fourths of the salary payable to the incumbent on that date, where he has exercised the option under section 4(2).”.</p>
6	<p>A. In paragraph (a), after the words “<b>inclusive of</b>” delete the words “<b>personal allowance and</b>”.</p> <p>B. In paragraph (c), delete the new section 11A and substitute the following new section:</p> <p style="padding-left: 40px;">“Review of pension      <b>11A. A person, including a retired Judge, is eligible on every fifth anniversary of the date he ceased to be a Judge for a revised pension –</b></p> <p style="padding-left: 80px;">(a) calculated on the basis of the pensionable emoluments payable to the incumbent on that date; or</p> <p style="padding-left: 80px;">(b) at the rate of three-fourths of the revised pension payable under paragraph (a), where he has exercised the option under section 11(1).”.</p>
7	<p>A. Delete.</p> <p>B. Renumber clauses accordingly.</p>
8	<p>In paragraph (b), insert after the word “<b>prescribe</b>”, the words “, <b>except that an Order under this paragraph shall not affect a person who is registered under subsection (1) prior to the coming into force of the Order</b>”.</p>
9	<p>In subsection (7), delete the word “<b>(1)</b>” and substitute the word “<b>(6)</b>”.</p>
