THE APPROPRIATION (FINANCIAL YEAR 2022) BILL, 2021

Explanatory Note

(This note forms no part of the Bill but is intended only to indicate its general purport)

The Bill seeks to provide for the service of Trinidad and Tobago for the financial year ending September 30, 2022 by authorising the issue from the Consolidated Fund of the sum of Forty-Three Thousand, Eight Hundred and Five Million, One Hundred and Seven Thousand, Four Hundred and Fifty-Five Dollars (\$43,805,107,455).

BILL

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows:

1. This Act may be cited as the Appropriation Short title
(Financial Year 2022) Act, 2021.

Issue from the
Consolidated Fund
authorised

2. (1) The issue from the Consolidated Fund of the sum of Forty-Three Thousand, Eight Hundred and Five Million, One Hundred and Seven Thousand, Four Hundred and Fifty-Five Dollars (\$43,805,107,455) is authorised for meeting expenditure for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2022, under the Heads of Expenditure specified in the First Column of the Schedule.

Schedule

(2) The sum specified in the Second Column of the Schedule, in relation to the Head of Expenditure specified in the First Column of the Schedule, is appropriated out of the sum of Forty-Three Thousand, Eight Hundred and Five Million, One Hundred and Seven Thousand, Four Hundred and Fifty-Five Dollars (\$43,805,107,455) for the service of Trinidad and Tobago for the financial year ending on the 30th day of September, 2022.

Commencement

3. This Act is deemed to have come into force on the 1st day of October, 2021.
