THE MISCELLANEOUS PROVISIONS (HERITAGE PETROLEUM,
PARIA FUEL TRADING AND GUARACARA REFINING
VESTING) (AMENDMENT) BILL, 2026

Explanatory Note

(These notes form no part of the Bill but are intended only to
indicate its general purport)

This Bill seeks to amend the Miscellaneous Provisions (Heritage Petroleum, Paria Fuel Trading and Guaracara Refining Vesting) Act, 2018 (Act No. 17 of 2018), to provide for the continuation of all collective agreements to which PETROTRIN was a party and to deem Heritage Petroleum Company Limited and Paria Fuel Trading Company Limited to be the successors to PETROTRIN for the purposes of those collective agreements and the Industrial Relations Act, Chap. 88:01.

Clause 1 would provide for the short title of the proposed Act.

Clause 2 would provide for the proposed Act to be deemed to have come into force on the 1st day of December, 2018.

Clause 3 would insert a new section 7A into the Miscellaneous Provisions (Heritage Petroleum, Paria Fuel Trading and Guaracara Refining Vesting) Act, 2018, to provide for the continuation of all collective agreements to which PETROTRIN was a party and to deem Heritage Petroleum Company Limited and Paria Fuel Trading Company Limited to be the successors to PETROTRIN for the purposes of those collective agreements and the Industrial Relations Act, Chap. 88:01.

Enacted by the Parliament of Trinidad and Tobago as Enactment
follows:

1. This Act may be cited as the Miscellaneous Short title
Provisions (Heritage Petroleum, Paria Fuel Trading and
Guaracara Refining Vesting) (Amendment) Act, 2026.

Commencement

2. This Act is deemed to have come into force on the 1st day of December, 2018.

3. The Miscellaneous Provisions (Heritage Petroleum, Paria Fuel Trading and Guaracara Refining Vesting) Act, 2018 is amended by inserting after section 7, the following section:

“Continuation
of collective
agreements

7A. (1) All collective agreements within the meaning of the Industrial Relations Act, or any replacement or modification thereof in existence before the appointed day, to which PETROTRIN was a party shall be construed and have effect as if Heritage Petroleum Company Limited and Paria Fuel Trading Company Limited were parties thereto, and for the purposes of those agreements and of that Act, Heritage Petroleum Company Limited and Paria Fuel Trading Company Limited shall be deemed to be the successors to PETROTRIN.”.

(2) Subject to the Industrial Relations Act, the OWTU which, immediately prior to the appointed day, was the recognised majority union representing the workers who were employed in PETROTRIN, shall continue to be the recognised majority union representing workers in Heritage Petroleum Company Limited and Paria Fuel Trading Company Limited for the purposes of the collective agreements referred to in subsection (1).

(3) In this section, “OWTU” means the Oilfield Workers Trade Union.
